apa style article - vanguard university - 2 a. pagination: the abstract begins on a new page (page 2). b. heading: "Abstract" (centered on the first line below the running head) c. format: the abstract (in block format) begins on the line following the abstract heading. the abstract word limit is set by individual journals. typically, the word limit is between 150 and 250 words. all numbers in the abstract (except those beginning ...
